Road signs: Misreading / ignoring / speed humps

I would suggest from time to time some motorists ignore road signs. I was recently at a country park. The road which two young motorists drove along had a 'no entry' sign at the entry point. Without hesitation the first driver drove past the no-entry signs, closely followed by the second car - he had probably noticed the signs, but chose to continue because his 'mate' had drove past the signs, not wishing to use the correct exit. Fortunately, no one was about to use the one-way street in the usual way in order to drive to more remote car-parks, as most vehicles were approaching the exit, as closing time was nearing.

On another occasion, at a point where a busy road was closed in one direction, several motorists approaching the 'road closed', 'no entry' and 'diversion' signs along with a copious number of cones, still attempted to drive past the closure signs. Incidentally, these motorists were encouraged to choose another route, although with some, it was an uphill task to explain alternative routes to their destination. It may be that motorists are creatures of habit - they have driven along stretches of road hundreds of times, so they may become oblivious to road signs or changes. Reported instances where road crews working on road works have experienced close calls from speeding motorists driving through restricted areas, for example, on motorways where the speed limit had been reduced to 40mph. Over the years, it has become necessary to install safety cameras to slow motorists down to protect road crews. Imagine for a moment working close to the edge of a line of cones, with motorists travelling through the hazardous area maintaining their normal road speed without any thought for anyone. It must be an awful experience. As for speed limits, I would suggest most motorists, at some time or other, will break a speed limit - not intentionally, but will drift slightly above the signed limit. It's the ones that have total disregard for speed limits which can cause problems for themselves and other road users. In some areas, councils attempt to control the problem of speeding motorists by installing road humps - in a variety of shapes and sizes. Some are speed cushions, others spread across the road in the form of a speed table and chicanes, where it is necessary to drive a course through kerbs and bollards. So, the majority of law abiding motorists have to negotiate the newly added features, which also provides an uncomfortable journey, because a few have chosen to travel at excessive speed over an extended period of time, perhaps past schools, or through villages where pedestrians are put at risk.

It is very difficult to evaluate the benefit of this activity from our point of view but we certainly need to keep the name of the Institute of Advanced Motorists in front of the general public, a few months ago the BBC Midlands ran a road safety campaign called Drive to Survive, this was a comprehensive campaign promoted primarily through the radio, we managed to get Les Ross who presents an afternoon show to take a IAM mock test, I sat in the back of Les Ross's Mini Cooper (original model) while staff examiner Mike Lovelock took Les through the test procedure, we all felt it was a very worthwhile exercise and Les himself did extremely well. During that week the test was featured on air and people phoned in to discuss driving technique, and road safety in general, towards the end of that week Peter Plisner, the motoring correspondent for BBC Midlands took a similar test which was shown on Midlands today, we feel therefore that we did gain good publicity through the BBC Midlands campaign Drive to Survive for the IAM.

We feel this type of activity is essential we certainly need to keep the name of the Institute of Advanced Motorists in the front of the general public.

We had a stand at the Wolverhampton show unfortunately it didn't seem to create the interest that we would have liked but at the same time we were there, we also had a stand booked at the Classic Car and Transport show at Himley for 7th of September, unfortunately the weather before the event was so bad, that the organisers decided to cancel the event, we did feel that particular show would have created an interest in the IAM, on the basis that it would be car minded people attending, we hope to attend that event next year and possibly similar events in our area, the committee feel that we need to create as much interest for members as is possible, we will be looking at a number of events that hopefully will be of interest to everyone

THE ADVANCED DRIVING TEST

What the Examiner expects

The Test takes about 90 minutes, over all types of roads and using your own car. The four essential qualities are **Concentration**, **Observation**, **Anticipation** and **Planning**. The Examiner is the holder of a Police Advanced Driving Certificate. A full understanding of what is expected can be found in the IAM publication "Pass Your Advanced Driving Test" or "Pass Your Advanced Motorcycling Test" as appropriate. A number of important points are mentioned here:

THE PRINCIPLES OF ADVANCED DRIVING

- Do you concentrate properly and avoid distractions?
- Can you read the road and anticipate potential hazards in good time?
- Are hazards dealt with in a planned and systematic way?
- Do you use your mirrors before changing your speed or position and do you always give a signal to other road users if they will benefit or appreciate one?
- Can you drive with reasonable restraint, but not indecision?
- Is your judgement of speed and distance accurate?
- Do you drive with courtesy and consideration for other road users, including pedestrians?
- Are you always in the right place on the road, travelling at the right speed with the right gear engaged and able to stop safely in the distance you can see to be clear?

HANDLING SKILLS

- Are steering actions safe, smooth and accurate, and do you pass the wheel through your hands?
- Are gears smoothly and correctly selected?
- Do you make full use of automatic transmission, if your car is fitted with it?
- Is your braking smooth and progressive?
- Do you use "acceleration sense"?

ADVANCED DRIVING SKILLS ON THE ROAD

- Do you keep up a reasonable pace and maintain good progress if conditions permit?
- Do you anticipate and react correctly to the situations developing ahead?
- Are the correct road position chosen and signals given in good time for the next manoeuvre?
- Are all signals, signs and road markings observed, obeyed and approached correctly?
- Are overtaking manoeuvres carried out smoothly, decisively and safely?
- Do you drive with proper restraint and proper sensitivity of control when the roads are slippery or visibility is reduced?
- Are manoeuvres such as parking, reversing, carried out smoothly and competently with effective all-round observations?

Advanced Drivers are expected to control the risks, despite the incorrect actions of others. Every journey can have its unexpected moments.

However, even successful candidates have made minor mistakes, which did not prevent them from passing the Advanced Driving Test.


New Members - are required to complete the Group Membership Form which will be sent to you upon contacting our Group.
