Lights – another visit 2010

If your vehicle has a defective light for instance, you may be stopped by the Police and be given 7 days to rectify the fault(s). You would need to visit an MoT Testing Station to either correct the defects, or to check that the defects have been corrected – and for a fee, I suppose, they would give you the necessary documentation to present to the designated Police station that the fault(s) had been corrected.

That would be the end of the matter if the necessary jobs had been completed during the 7 day period. However it would be a different story if you were unable to have the jobs attended to during this 7 day window.

Whilst visiting business premises recently, the owner of the car was told there was a defective headlight. 'Ok' was the answer – 'How much will that cost, please?' 'About £100 plus the cost of the bulb!' 'How much did you say?', the driver asked. 'About £100 plus the cost of the bulb: On this type of vehicle, it's necessary to remove the bumper to replace the headlight bulb'. The owner was staggered – understandably.

The garage was not a dealership premises whose prices are usually somewhat higher—this was a garage you may choose to use for servicing if your car is a little older.

I'd like to suggest this car, from a major manufacturer, is not the only one to attract exceptional costs when replacing low value items.

If, as a driver you made periodic checks to ensure lights were working, you could avoid the additional expense of the MoT garage and the necessary certificate for the Police.

Recently, driving along in a line of traffic, I noticed the van ahead of me wasn't showing any brake lights when traffic ahead began slowing down. The situation didn't take me by surprise as I had been viewing the traffic ahead wondering why everyone was travelling so slowly in a 40mph area. I had seen the vehicles ahead showing their brake lights, but not the van directly ahead of me. I followed the van for a short distance: at a T junction, he turned right, I needed to turn left. We were both held up by red traffic lights. It was at this point this that I attracted his attention and mentioned that he didn't have any brake lights. The driver was unaware of the situation. 'Oh! Thanks mate', was his reply. (Yes, really)

New limit must not dilute police enforcement of drink driving, says IAM

The IAM (Institute of Advanced Motorists), the UK's largest independent road safety charity, has today welcomed the proposal of a new lower drink drive limit, but stresses that enforcement will be the key factor that determines its success.

Commenting on the findings of the North Report, released today, IAM Director of Policy and Research Neil Greig said: "Authorities should be aware that, should it pass into law, a new limit will make little difference to casualty figures without proper enforcement. Already stretched front line police may end up pursuing lower risk drivers, leaving less time to catch those who blatantly ignore any limit."

Mr Greig continued: "A lower limit will hopefully make many more drivers think twice about taking any drink at all before getting behind the wheel. Drivers will also be more likely to get caught the morning after, but only if sufficient police are out there enforcing the law.

"Many repeat offenders think they're invincible, and ultimately it is fear of being caught that will eradicate drink driving rather than stronger penalties." "...and those of the general public

THE ADVANCED DRIVING TEST

What the Examiner expects

The Test takes about 90 minutes, over all types of roads and using your own car. The four essential qualities are **Concentration**, **Observation**, **Anticipation** and **Planning**. The Examiner is the holder of a Police Advanced Driving Certificate. A full understanding of what is expected can be found in the IAM publication "Pass Your Advanced Driving Test" or "Pass Your Advanced Motorcycling Test" as appropriate. A number of important points are mentioned here:

THE PRINCIPLES OF ADVANCED DRIVING

- Do you concentrate properly and avoid distractions?
- Can you read the road and anticipate potential hazards in good time?
- Are hazards dealt with in a planned and systematic way?
- Do you use your mirrors before changing your speed or position and do you always give a signal to other road users if they will benefit or appreciate one?
- Can you drive with reasonable restraint, but not indecision?
- Is your judgement of speed and distance accurate?
- Do you drive with courtesy and consideration for other road users, including pedestrians?
- Are you always in the right place on the road, travelling at the right speed with the right gear engaged and able to stop safely in the distance you can see to be clear?

HANDLING SKILLS

- Are steering actions safe, smooth and accurate, and do you pass the wheel through your hands?
- Are gears smoothly and correctly selected?
- Do you make full use of automatic transmission, if your car is fitted with it?
- Is your braking smooth and progressive?
- Do you use "acceleration sense"?

ADVANCED DRIVING SKILLS ON THE ROAD

- Do you keep up a reasonable pace and maintain good progress if conditions permit?
- Do you anticipate and react correctly to the situations developing ahead?
- Are the correct road position chosen and signals given in good time for the next manoeuvre?
- Are all signals, signs and road markings observed, obeyed and approached correctly?
- Are overtaking manoeuvres carried out smoothly, decisively and safely?
- Do you drive with proper restraint and proper sensitivity of control when the roads are slippery or visibility is reduced?
- Are manoeuvres such as parking, reversing, carried out smoothly and competently with effective all-round observations?

Advanced Drivers are expected to control the risks, despite the incorrect actions of others. Every journey can have its unexpected moments.

However, even successful candidates have made minor mistakes, which did not prevent them from passing the Advanced Driving Test.


New Members - are required to complete the Group Membership Form which will be sent to you upon contacting our Group.
