Full and Associate Members—please note - that a valid Group Membership card must be produced upon request. Failure to do so or if the card is invalid, that particular activity shall not take place.

IAM Documents Declaration Forms—<u>must</u> be completed by the Associate at the first run. Attendance at 'Associate Evenings' by Associate Members—is required.

Do remember - When you have taken a 'pre-test' drive - and have been recommended to apply for your actual IAM Test. This recommendation will come from you having demonstrated the standard that we expect of you to pass - however - it will still depend on your driving on the actual day of your IAM test with an IAM Examiner. Your actual Test application will done via the IAM DTE database and the group's database user. Within 2-3 weeks - an Examiner will contact you to arrange a date, time and location for your actual test.

After taking your test - please let your Observer <u>and</u> Chief Observer know of the result as soon as possible. This allows us to say 'well done' — and to free your Observer for any waiting Associate.

Observers— tell your Chief Observer when your Associate passes—as we would much rather be told twice than not at all!

Recently I had occasion to park on a local supermarket car park whilst the wife went inside to do some shopping. It was a busy time of day, but after driving around a couple of times I eventuality managed to find a space and "reverse parked "into it.

As I settled down, expecting to be there for some time, I observed other motorists doing the same as I had done, slowly making 2/3 circuits of the car park looking for spaces.

Suddenly my attention was drawn to a Mercedes coupe, roof open and with sound system blasting away, doing the circuit at a speed, I would suggest, not appropriate to the surroundings of a busy car park and all the potential hazards that there could be. As he passed me for about the third time, I noticed through the corner of my right eye, a car with an elderly gentleman commencing to reverse out of a parking bay, straight into the path of our Mercedes man. The inevitable happened, no one injured, but damage to both vehicles especially the Merc. Needless to say the driver did not appear to be too happy, surveying his battered pride and joy.

This set me thinking. We all need to be a 'thinking' driver at all times.

Use IPSGA, - "work the system, and the system will work for you".

The driver of the Merc obviously had not used the system-by not interpreting and using the information that was available to him when he entered the car park. As a responsible, thinking driver, one would expect to encounter pedestrians, children, Mothers with prams etc. As for the other driver, should he have reversed out of a parking bay if unsafe to do so? If in doubt why not ask someone to guide him out.

But better still why not do as we as advanced driver's do- Reverse in, drive out.

Are you using TPSGA' — gathering and using available information?

OBSERVERS AND ASSOCIATES - PLEASE NOTE: Do read the Events and Meetings sections as there are evenings that you are required to attend. Equally regularly check vour email and Group Website for (www.wolvesiam.org) and changed dates/times! coming Ooops!' - is not a reasonable response to a missed attendance, don't you know!

ASSOCIATE RESPONSIBILITIES

Attendance at Associate Evenings—is required.

Keep in touch with your Observer—it is your responsibility to do so.

If you cannot keep an appointment— tell your observer. Observers work on a voluntary basis and have lives of their own to fit around their observing. It is only courteous to let them

know in a timely manner.

If you do not keep in touch with your observer—it will be assumed that you no longer wish to continue and your observer will be assigned to another associate. Our observers and their time are a scarce commodity so we have to make best use of them.

A successful pre-test

run—still means that you continue your observed runs right up to the actual test. Do not go off the boil!

When you pass your test—let us know via your observer so that all the group can celebrate your success.

Visit to the Regional Traffic Control Centre

On a slightly chilly Wednesday evening in March, just as the rush hour traffic was finishing we arrived at the Quinton RTCC for our visit. Our Group was in the very privileged position to have a special arranged visit. Unlike so many others who go there they get a very brief look in lasting about 40 to 50 minutes.

Similarly a visit to the adjacent National Traffic Control centre last a similar amount of time. For ours we had one of the top Managers Rob and one of his staff gave us not only the usual high level visit.

There Centre became operational back in 2005. But a more detailed explanation of what the Highways Agency staff, have to meet as targets, what their roles comprise of on a day to day basis. The Centre is one of 5 Nationwide and the Control room is manned 24 hours a day by a number of teams each with a specific area of skill expertise and responsibility all under control of the Shift Manager. This is achieved by three teams both inside the centre and its control room and through the on Road Officers.

- What happens when a serious incident or multiple incidents occur?
- How the design of motorways has changed.
- The risks and issues which are often wrongly associated with all lane running carriageways.
- The range and number of incidents they deal with is a significant number every day.
- They reminded us that all of the issues they face come about through the actions, errors and miss-judgements of Individuals who drive vehicles.
- We were reminded of the importance of having breakdown and roadside recovery insurance options for your vehicles if you drive them on the Motorway and the potential costs and consequences of not having it, should they need use their removal contractors.
- That hard shoulders are not a safe place and that is its essential you leave your vehicle whatever the weather or time of day to a safer place behind a barrier and ideally up an embankment.
- when drivers call in for assistance using their mobile phones, they are not always sure where they are (or even what motorway they are using), this can delay their recovery

We were then privileged to look right behind the scenes and with the permission of the evening top Manager a visit into the actual control room during its operation. Sadly no pictures were permitted to be able to share with you.

We were given a detailed understanding of the specific areas and teams on duty what which was responsible for and actually doing. A view of the large and multiple displays they have and a look at the multiple CCTV streamed pictures they have.

We got to look closely at one of the spare patrol vehicle. Understand the criteria behind the model selection. The lights and variable message board on the rear. They are only class 2 response vehicle drivers meaning they cannot break the speed limit, even on the way to incidents. They also have quite aggressive phone answering and incident response times. The equipment that the vehicles carry includes their self-sequencing (strobing) yellow hazard lights. Some of the other things they carry such as pop-up directional signs, traffic cones. The lights have both day and nightlight level settings.

Our visit was over three hours in total but the time passed by so quickly thanks to the informative and interesting hosts we had. This is another visit I would recommend to any Group members without hesitation and we are looking to re-book again within the next 12 months but on a Sunday afternoon next time.

GROUP 'TASTER' DRIVES

Though the option of free "Taster Drives" have been withdrawn by London we at the Wolver-hampton Group still believe that they are a valuable option that we should extend to as many people as possible; to this end we continue to offer, completely free of charge, taster drives to anyone with a valid UK driving licence, a legal road vehicle and an interest in improving road safety by improving their own driving skills.

As a recipient of this Newsletter you are already a Member of the IAM and understand the benefits that enhanced driving skills bring to not only your own driving pleasure but also to the safety of those around you including other road users.

The free taster-session option saves the normal £39 charge and is open to everyone; look at your friends and relatives and use the option to introduce them to the advantages that the IAM brings; this is not a hard-sell approach as the Observer who goes out with the driver will provide a realistic, objective appraisal of that persons driving and also, because of their experience be able to answer any questions that the individual may have about their driving and how they could improve their driving enjoyment.

Taster sessions can also be tailored if someone you know has a particular "concern" or "fear" of a certain driving condition, motorways, handling roundabouts, night driving being examples of these concerns.

We do need new Members and would welcome people from all age groups, total involvement time is around an hour and a half and could be the most useful hour and a half that person has spent since they did their original driving test.

As it's a 'free' option there is nothing to lose!

IAM—INFORMATION

THE ADVANCED DRIVING TEST

What the Examiner expects

The Test takes about 90 minutes, over all types of roads and using your own car. The four essential qualities are **Concentration**, **Observation**, **Anticipation** and **Planning**. The Examiner is the holder of a Police Advanced Driving Certificate. A full understanding of what is expected can be found in the IAM publication "Pass Your Advanced Driving Test" or "Pass Your Advanced Motorcycling Test" as appropriate. A number of important points are mentioned here:

THE PRINCIPLES OF ADVANCED DRIVING

- Do you concentrate properly and avoid distractions?
- Can you read the road and anticipate potential hazards in good time?
- Are hazards dealt with in a planned and systematic way?
- Do you use your mirrors before changing your speed or position and do you always give a signal to other road users if they will benefit or appreciate one?
- Can you drive with reasonable restraint, but not indecision?
- Is your judgement of speed and distance accurate?
- Do you drive with courtesy and consideration for other road users, including pedestrians?
- Are you always in the right place on the road, travelling at the right speed with the right gear engaged and able to stop safely in the distance you can see to be clear?

HANDLING SKILLS

- Are steering actions safe, smooth and accurate, and do you pass the wheel through your hands?
- Are gears smoothly and correctly selected?
- Do you make full use of automatic transmission, if your car is fitted with it?
- Is your braking smooth and progressive?
- Do you use "acceleration sense"?

ADVANCED DRIVING SKILLS ON THE ROAD

- Do you keep up a reasonable pace and maintain good progress if conditions permit?
- Do you anticipate and react correctly to the situations developing ahead?
- Are the correct road position chosen and signals given in good time for the next manoeuvre?
- Are all signals, signs and road markings observed, obeyed and approached correctly?
- Are overtaking manoeuvres carried out smoothly, decisively and safely?
- Do you drive with proper restraint and proper sensitivity of control when the roads are slippery or visibility is reduced?
- Are manoeuvres such as parking, reversing, carried out smoothly and competently with effective all-round observations?

Advanced Drivers are expected to control the risks, despite the incorrect actions of others. Every journey can have its unexpected moments.

However, even successful candidates have made minor mistakes, which did not prevent them from passing the Advanced Driving Test.


